## Awards

Awards will be given each day at the conclusion of the trial at the trial headquarters  
In order to keep costs to a minimum we are only giving out ribbons, no other plaques or awards

## Refunds, Cancellations

1. Refunds will be given if the event is canceled prior to the entry deadline.
2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Event Committee.
3. If, because of riots, civil disturbances, bad weather or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee may be made if necessary to cover non-refundable incurred expenses.
4. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. At that time the Officers of the GNEBGDC will make a ruling on refunds. No refunds will be made in such cases if necessary to cover incurred expenses.
5. Refunds will be given on a case by case basis if the dog has a Veterinarians note explaining why the dog is unable to be exhibited. The Officers of the GNEBGDC will be the deciding group.
6. The collection fee for returned checks is \$30.00.
